Pygmalion, Heartbreak House, and Saint Joan George Bernard Shaw, 2021 Pygmalion Heartbreak House and Saint Joan are widely considered to be three of the most important in the canon of modern British theatre Pygmalion 1912 was a world wide smash hit from the time of its premi re in Vienna 1913 and it has remained popular to this day Shaw was awarded an Academy Award in 1938 for his screenplay of the film adaptation It was of course later made into the much loved musical My Fair Lady Heartbreak House 1917 which was finally performed in 1920 and published in 1921 bares the hallmarks of European modernism and a formal break from Shaw s previous work A meditation on the war and the resultant decline in European aristocratic culture it was perhaps staged too soon after the conflict indeed it did not have the success of his
