State regulation of private schools however is not without limitations. The challenge to state legislators in regulating private schools is to draft legislation that 1 respects the fundamental right of parents to direct the education of their children 2 protects the state's interest in an informed citizenry but avoids interference with religious beliefs unless compelling interests are at issue and 3 avoids comprehensive regulation of private education that would deprive parents of any choice in education.
