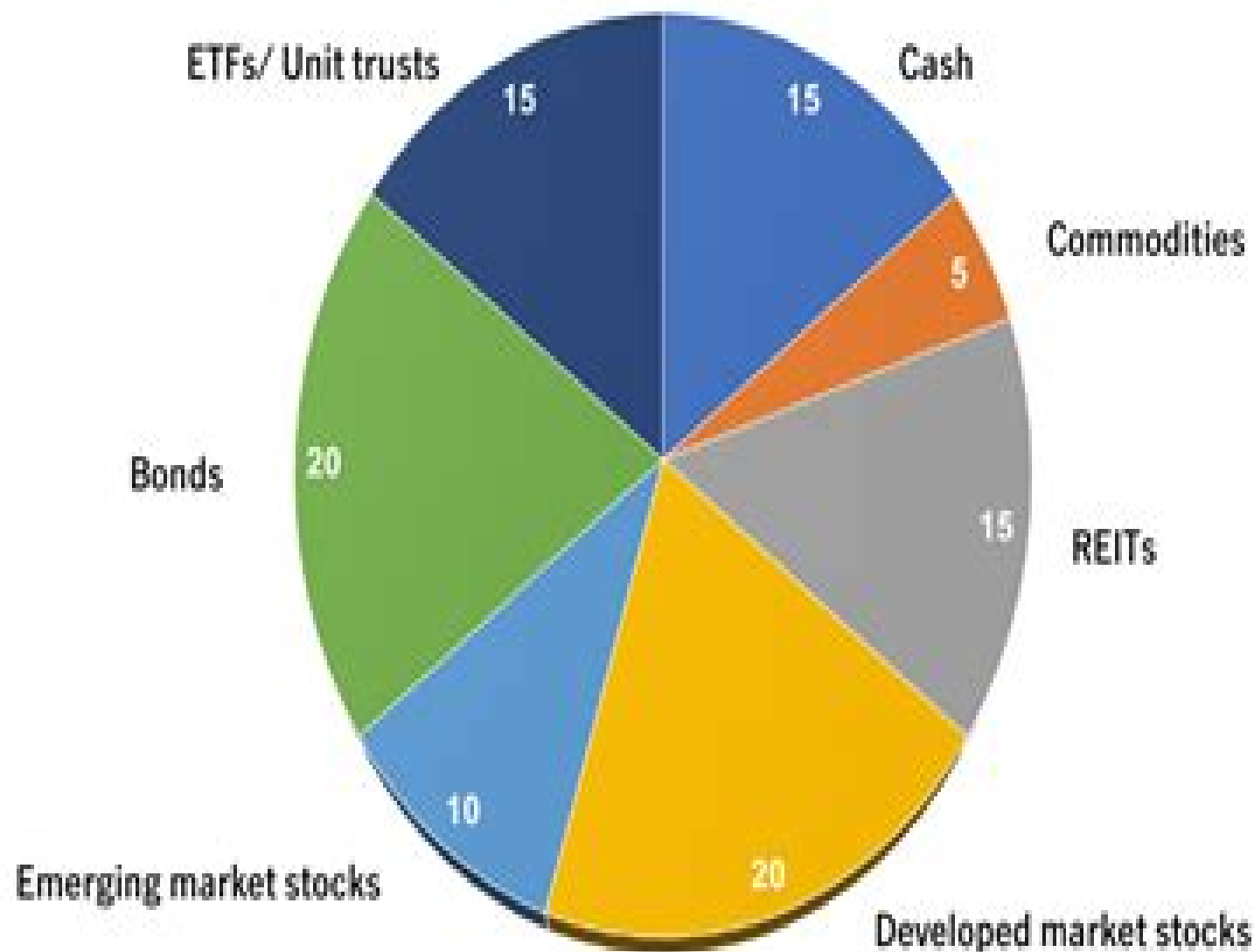


Example of Diversified Investment Portfolio (%)
