3 THEY USE RULES.

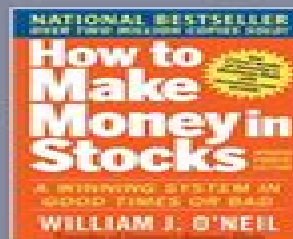
Use a set of clear-cut, actionable "if-then" rules to manage your portfolio and how you trade individual stocks.
