two groups of leading manufacturing firms referred to here as Japanese and or Vietnamese Chinese chains for accumulating strategic know how On the basis of historical evidence and recent empirical data collected through repeated rounds of in depth fieldwork the analysis finds first those suppliers learning trajectories evolved over time resulting in a divergence in learning performance extending across suppliers in later phases of industrial development In the later stage high performing suppliers amassed basic innovative expertise constituting the bedrock of this fast growing industry Second the analysis finds that the diverging performance can be explained by the combination of roles played by lead firms in inducing and facilitating supplier learning and those of suppliers in mobilizing their own sources of knowledge These conclusions not only provide dynamic insightful accounts of supplier learning in developing country contexts but also make key theoretical and methodological contributions to the research on value chain participation and supplier learning
