

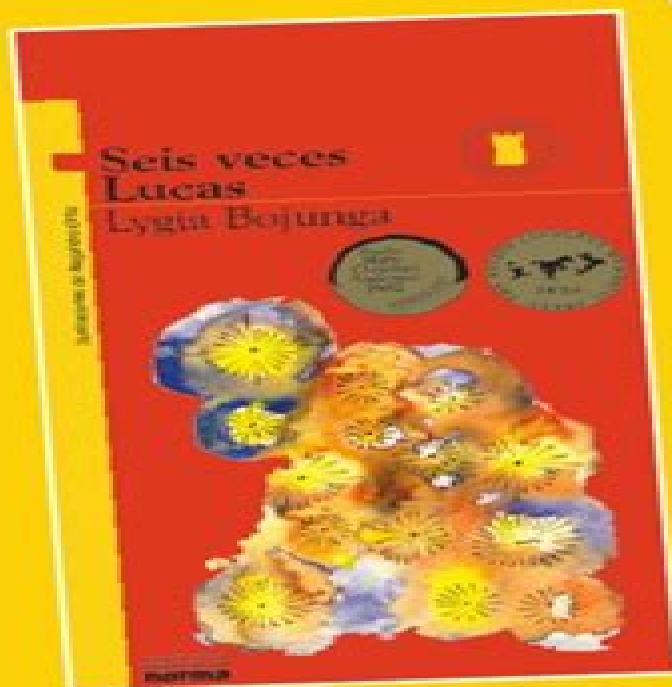

naturaleza del Padre y del hijo así como de su relación siendo que aunque la postura mayoritaria fue la mencionada incluso hasta nuestros días grupos pequeños de creyentes desperdigados por aquí y por allá a lo largo de los siglos han abrazado la postura minoritaria.
