Routine Procedures to be done as Symptoms of Approaching Death Develop:

1. Notify the doctor.
2. Notify relatives and friends.
3. Call for priest or minister.
4. Call supervisor and Headnurse.
5. Provide privacy (by screening if in the ward).

Procedure:

1. Warm the cooling extremities by the application of blankets and prevent draft.
2. See that the bedding is light in weight and when the gown is wet with perspiration should be changed.
3. Rub the skin gently with alcohol 70%
4. Place patient in a comfortable position preferably on his side and
