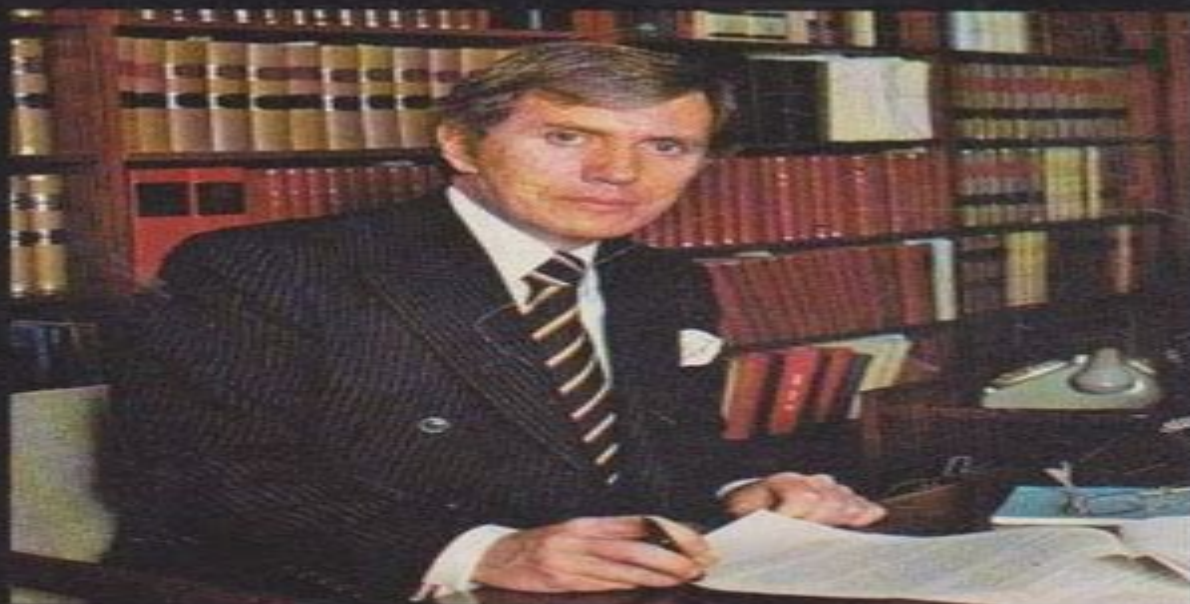

Michael Tilbury is Kerry Holdings Professor in Private Law in the Faculty of Law the University of Hong Kong. Simon N M Young is a professor in the Faculty of Law the University of Hong Kong and was formerly Director of the Centre for Comparative and Public Law.
