- the appropriate measures ABC Ltd could adopt as a private limited company to prevent existing members from transferring their shares to outsiders not approved by the board of directors.
- The difference between pre-emption clause in the articles of the company and statutory pre-emption provision under the Act.

- f. Complete and file Form SH01 with the Registrar of Companies within one month, detailing the new preference shares. (\$555)
