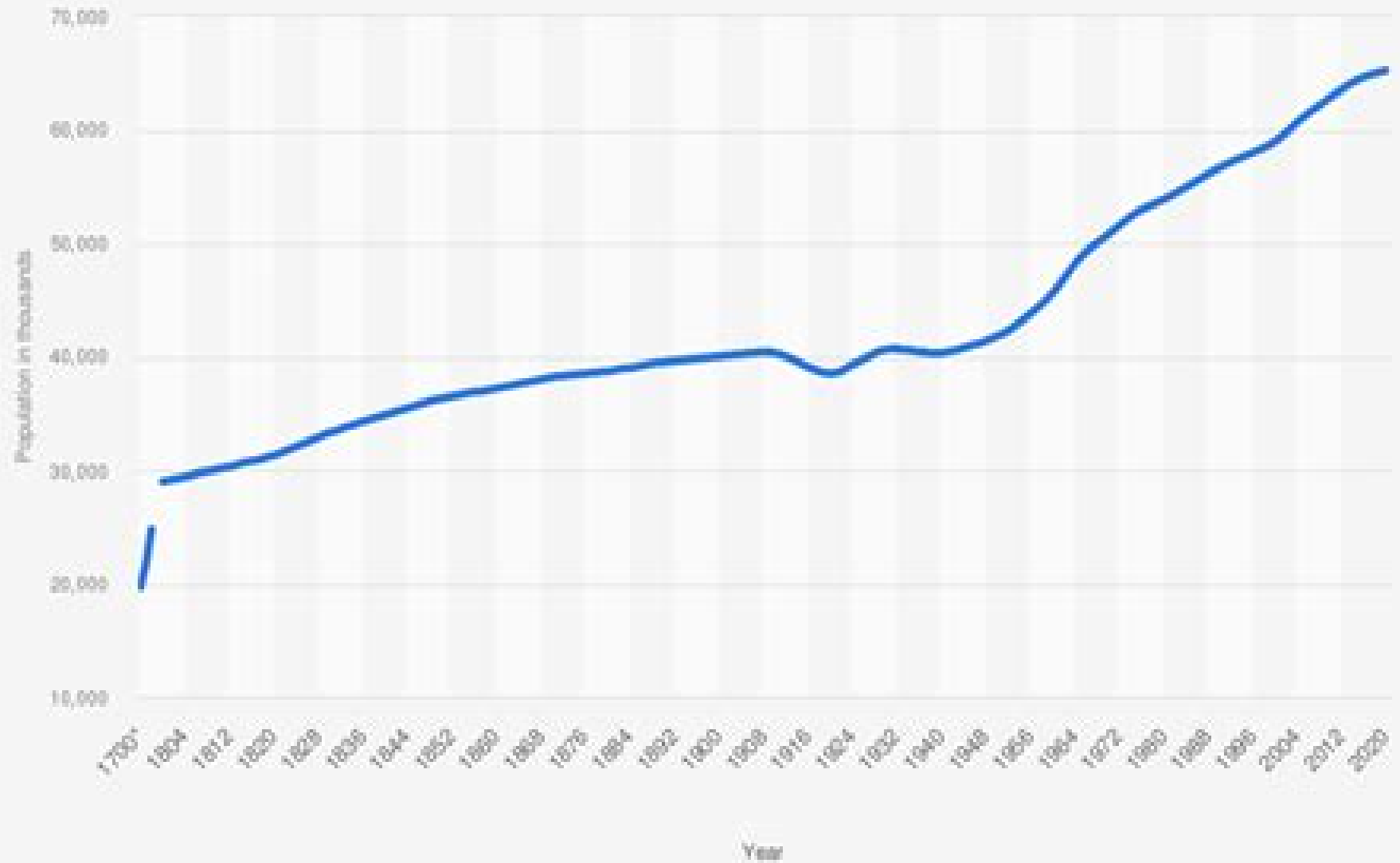


Population of France from 1700 to 2020 (in 1,000s)
