Incagnoli, 2013-06-29 This volume reflects in part an update of Clinical Application of Neuropsychological Test Batteries edited by Theresa Incagnoli Gerald Goldstein and Charles Golden some 10 years ago While the initial concept of the present editors involved doing a straightforward update of each chapter it soon became apparent that the field of clinical neuropsychology had changed so dramatically and rapidly that substantial changes in the outline had to be made It was our view that sufficient

interest remained in the standard comprehensive neuropsychological test batteries to make an update worthwhile. We asked four senior people to take on this assignment: James Moses Jr and Arnold Purisch in the case of the Luria Nebraska Battery and James Reed and Homer Reed for the Halstead-Reitan Battery.
