Settlements are desirable not just because trials are costly to litigants and court systems, but because settlements allow parties to manage their own disputes and avoid the uncertainties and limitations of the winner-take-all imposed decisions that courts make in fully litigated cases. Settlement also offers privacy to litigants and enables them to consider opportunities for resolutions that would not be available in a trial judgment.
