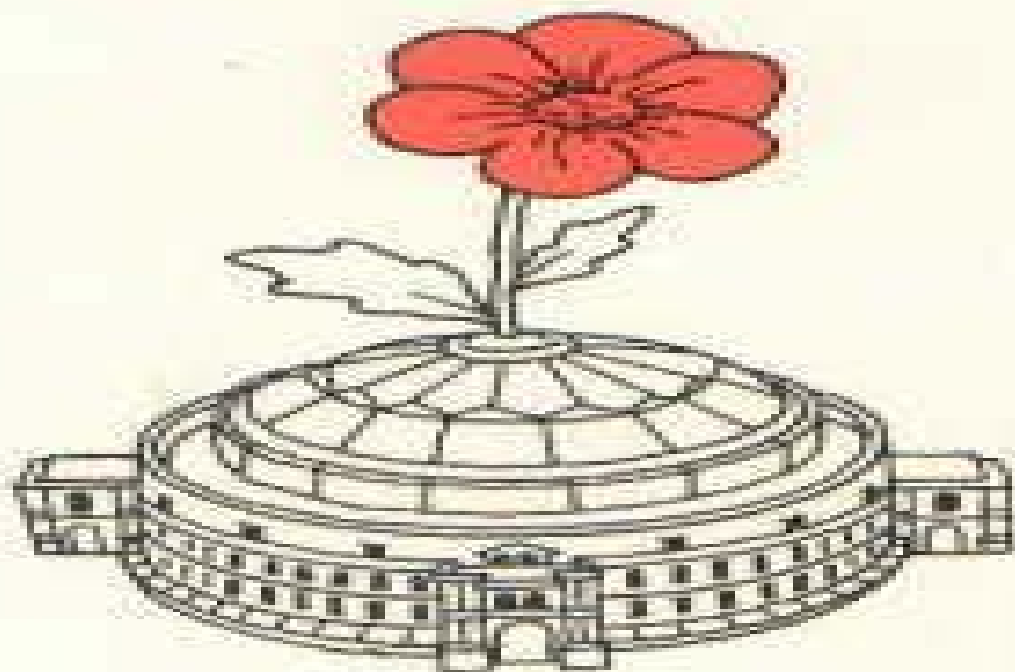

Once there it moves much of Firth's and Malinowski's thinking into a computational method based upon the ability of language to govern and analyse itself using collocation to plot its scope and limits. The focus is on the poet Alexander Pushkin whose authorial intention becomes computationally recoverable.
