Leibniz certainly recognized and thought through the problems associated with these words but he never developed a final coherent theory, a fact which certainly reflects in part the complexity of the underlying problems. By exploiting not only all the relevant Leibnizian writings but also the results of more recent philosophy in this field, Kulstad is able to draw a reliable picture both of Leibniz's treatment of these problems and of the influence of his views on his contemporaries and successors.
