The government of Aspatria denies these accusations and states that: (i) the interrogation techniques used by the Aspatrian authorities do not amount to torture within the meaning of the ICCPR; and (ii) Aspatria is presently at war with a neighbouring state and has proclaimed a state of emergency, accordingly it
