The shift toward oversight at the committee level combined with party leader control over the voting agenda means that many members of Congress are effectively cut out of many of the institution s policy decisions At a time when many including Congress itself are considering changes to modernize the institution and keep up with a stronger executive branch the findings here suggest that strengthening Congress will require more than running different candidates or providing additional resources The Acceptance of Party Unity in Parliamentary Democracies David M.
