in quality the Journal has left its mark on the landscape of scholarly journals The AHRLJ has provided a forum for African voices including those that needed to be fine tuned Different from many other peerreviewed journals the AHRLI has seen it as its responsibility to nurture emerging but not yet fully flourishing talent.
