Underlying his explanations is a belief in the importance of worldwide free trade and open markets, as well as a crucial understanding of the political forces that shape decision-making. Because economic policy is not created in a political vacuum, Dam argues, sound policymaking requires an understanding of statecraft, the creation and use of institutions that channel the efforts of interest groups and political forces in directions that encourage good economic outcomes.
