A purse snatching may dislocate the victim's shoulder or elbow, or lacerate her arm; a bicycle theft may injure the owner if the thief blocks his path or shoves the bike over to dislodge its rider; and so on. It was logical arguments of this kind, and not data, that won the day in Taylor and our escape cases. ... Thus Lee is out of line not only with other circuits, but also with how this circuit has analyzed related issues in later decisions such as Bryant and Franklin -

In order to bring harmony both within and among the circuits, we now overrule the portion of Lee dealing with the treatment of theft and hold that theft from a person is a violent felony under the Armed Career Criminal Act. The other principal holding of Lee--that classification must be based on the elements of the offense as revealed by the charging papers, rather than on the facts of the particular case-is compatible with Taylor and was adopted en banc by Shannon, 110 F.3d at 384-85. It remains good law. As an overruling opinion, this decision was circulated to all judges in regular active service. See Circuit Rule 40(e).
