Basic principles of justice are artificial because solving those problems does not require appeal to moral realism nor to moral anti-realism. Instead, moral cognitivism is preserved by identifying sufficient justifying reasons which can be addressed to all parties for the minimum sufficient legitimate principles and institutions required to provide and protect basic forms of social coordination including verbal behaviour. Hume first develops this kind of constructivism for basic property rights and for government. Kant greatly refines Hume's construction of justice within his metaphysical principles of justice whilst preserving the core model of Hume's innovative constructivism.
