- Pooled Investment Fund an investment vehicle that pools together money from many investors and invests that money in a variety of securities.
  - Example if you wish to purchase a board lot (100 shares) of a stock that is currently trading at \$20/share, you will need to spend \$2000 (20x100 shares).
    - Pooled investments are arranged such that you are able to pool your money with other investors in order to purchase many types of stock and bond investments throughout the world.
  - Mutual funds, Exchange traded funds (ETFs) and segregated funds.
    - The minimum initial investment in a mutual fund is usually between \$500-\$5000, depending on the fund.
- Equity Mutual Funds funds that sell units, or shares, to individuals and use this money to invest in stocks.
- Bond Mutual Funds funds that sell units, or shares, to individuals and use this money to invest in bonds.
- Balanced Mutual Funds funds that sell units, or shares, to individuals and use this
  money to invest in a COMBINATION of stocks and bonds.
- Money Market Mutual Funds (MMFs) funds that sell units, or shares, to individuals and
  use this money to invest in cash and investments that can be converted to CASH quickly
  (very liquid investments).
