He developed this theory for his PhD dissertation at Yale University, graduated 1963, of which his first book *God the Creator* constitutes a substantial revision. Exploring the implications of that theory has enabled him to produce a philosophy of nature that rivals Alfred North Whitehead's in scope and power as can be seen from his three-volume *Axiology of Thinking*.
