- Global protectionism rarely based simply on objective economic calculation
- Rationale underpinning it is predominantly political and strategic
- Seeks to allow countries to benefit from globalization while minimizing exposure to its challenges
 - Retain control over critical resources
 - Ensure national security
 - Manage economic prosperity in an increasingly competitive environment
 - Maintain national identity seen under threat from globalization
 - Such aims are encouraging economic nationalism – the use of economic policy instruments to increase national power and unity
 - Governments are increasingly developing new policy interventions to protect what they define as their national interests.
