- Only new requests when information needs to be used as evidence in Court. Otherwise a general request.

**The Premises of International Criminal Procedure** Megumi Ochi, 2024-11-22 How does international criminal procedure differ from any domestic legal principles and why? What premises of international criminal procedure do give rise to such differences? Can we provide any unified socio-legal explanation for the differences between the procedure of the International Criminal Court and the domestic legal principles? This boils down to the question what are the premises inherent in international criminal procedure? Applying the premise theory of general principles of law this book conducts a comparative analysis of various general principles of international criminal procedure with corresponding principles that are valid domestically and in general international law and identifies special premises in the procedural law of the ICC. The ICC's institutional premises of the value of expeditiousness and lacking centralized control over its limbs have had a significant impact on the various aspects of international criminal procedure.
