majoritarian public policy outcomes In the empirical chapters Franko and Witko examine how these factors have shaped policies that boosted incomes at the bottom the minimum wage and the Earned Income Tax Credit and reduce incomes at the top with top marginal tax rates between 1987 and 2010 The authors argue that if history is a guide increasingly egalitarian policies at the state level will spread to other states and eventually to the federal level setting the stage for a more equitable future
