Corporations have been under increasing social pressure in recent years to take a more active role in funding nonprofit educational and civic institutions. Attacks have also been made on the United States economic "system" for improperly exploiting the Nation's water, air and other natural resources. The underlying thesis for all such demands or complaints is that business corporations have an obligation to meet social needs as distinguished from economic needs. Whether such a thesis is sound, and if so, what standards corporations should use in determining which social obligations they should meet and how to meet them are questions to which corporate managers, fund raisers for nonprofit groups and other reformers alike are seeking answers. Three short papers recently published under the promising title, *A New Rationale For Corporate Social Policy*, regretfully do not provide much help in understanding or resolving these issues.

Apparently concerned with the charges that corporations are insufficiently involved in the current "social revolution," the authors attempt to explain why corporations should be more generous in their giving and more active in responding to social needs which are not easily translated into economic demand. They appear to presume that most corporations are opposed to involvement in, or otherwise supporting, activities which are not directly profit oriented. Each of the authors then attempts to justify, from a purely economic point of view, a change of such corporate policy.

Mr. Baumol, professor of economics at Princeton University, wrote the paper, "Enlightened Self-Interest and Corporate Philanthropy." He briefly records the history of corporate contributions and points out that corporations in recent years have given away about 1% of their profits. He
