Sandra Nichols Found Dead

*Body of Enfield Socialite Missing Five
Months Found in Nearby Bay State*

The badly decomposed body of a woman found yesterday in Andover has been identified as that of Sandra Nichols, who was reported missing five months ago from her New Hampshire residence. The victim, wife of Peter Wade and mother of three children by a former marriage, was ruled a death by homicide by the Massachusetts Commissioner's Office. A severe blow to the head with a blunt instrument is said to be the primary cause of death pending further investigation.

The victim's husband is being questioned by the police, although there is no official word as to whether he is considered a suspect. Mr. Wade had checked into the Glyndebourne Lodge and was said to be at the Lodge at the time of his disappearance.
