 - The system of rules, laws, and methods put in place by society to answer the 3 Fundamental Economic Questions:
- 1. What is Produce?
- 2. How to Produce it?
- 3. For Whom are the goods produced?
 - 2 Different Methods are employed by all advanced societies to answer the fundamental economic questions:
 - Government: The decision making unit within a society that has an exclusive right to use coercion or non-voluntary means in interactions between members of society
 - Market: The collection of all buyers and sellers of a good who interact voluntarily with each other
 - Definition of Capitalism and Socialism
 - Socialism: an economic system based on private ownership of the factors or means of production
 - Synonym: free market system

Chapter 3: Capitalism vs. Socialism

- Private Property, or the Private Ownership of property (including the means of production) consists of 3 interlocking rights:
- The Right of Control and Exclusive Use
- 2. The Right to Acquire or Transfer Property
- 3. Right to Restitution for Damages to one's property
 - o What is property?
 - Property is any of the external things of this world that are subject to ownership
 - EX: cars, bonds, houses, computers, computer businesses, trademarks
- Private Property as a Natural Right
 - A Natural Right is a right that exists by Natural Law
 - Natural Law is a belief that rights inherent in human nature and discoverable by reason rather than revolution
 - Natural Rights are rights to be free from arbitrary interference of others, including the state. This is often referred to as being free or having negative rights.
 - EX of natural, negative rights: private property, freedom of religion
