

Shakespeare was born on April 23, 1564, in Stratford, England, into a prosperous family of wool and leather merchants. His father, John, was also a minor gentry official in the area. There is practically nothing known of his early life and the next time that his name appeared officially was in 1582 when he married Anne Hathaway. Although there is no clear record of when, why or how he became interested in the theatre, it is known that he spent the time between 1584 and 1587 as an actor, stage manager and "provider of plays" for acting companies near Stratford.

are left Stratford in 1586 and arrived in London the following year. He became the stage manager of *The Theatre*, which was at the time the leading company in London. Soon after, he joined the acting company of *The Theatre*. Richard Burbage and William Kemp performed at court in many plays. Shakespeare's earliest works were produced in 1591-92; several of the Histories, *Titus Andronicus*, *Romeo and Juliet*, *Two Gentlemen of Verona* and *Comedy of Errors*.
