"Public policy is a course of government action or inaction in response topublic problems" (Kraft & Furlong)

"A standing decision characterized by behavioral consistency andrepetitiveness on the part of both those who make it and those who abide byit" (Eulau & Prewitt)

Public policy instruments:

Policy formulation - means coming up with an approach to solving a problem.
