Middlesex Die Hards to the modern Princess of Wales's Royal Regiment but the harsh reality is that those ties are only as strong as the men who made them. Like it or not the old and bold soldiers are a dwindling band and once they have fallen out for the last time the regiments will be truly lost. For this reason Trevor Royle now explores the histories of the many regiments that have disappeared to celebrate their existence as well as the men and officers who served with distinction within them.
