responsibilities are delegated to lower paid less trained workers Nevertheless the image of blue collar industrial workers organizing into unions is not easily reconciled with our society's image of physicians as highly trained and highly skilled members of a profession long considered the bastion of individualists Budrys suggests that doctors unions in general and the UAPD in particular may provide a model for other nontraditional groups and occupations seeking solutions to contemporary problems in the workplace After discussing the laws governing workers organizing rights and their interpretation by the courts she concludes with commentary on the organizing activity taking place among highly paid and highly educated workers
