Table 10.4 Summary of Discounted Cash Flow Valuation of Bonds, Preferred Stock, and Common Stock

Bonds and preferred stock state a promised cash payment to the security holder. In the case of a bond, interest and principal must be paid in accordance with the terms of the bond contract provided. Preferred shares have stated dividend rates, which when multiplied by the face or par value of the preferred stock, yield the promised preferred dividend. Both bonds and preferred stock are valued by discounting these promised cash flows back to the present. However, since these are promised (and not expected) cash flows, we discount the cash flows using promised rate of return as reflected in current market prices of similar securities. Common stock, on the other hand, does not have a contractual promised dividend payment, so we state the discounted cash flow based on the interest by estimating expected future dividends and then discounting them back to the present, using the expected rate of return that an investor would require if investing in a stock with the risk attributes of the shares being valued.
