Introduction

Recently, several new measures have been taken by Japan's Ministry of Health and Welfare (MHW) to ensure that good quality, safe and effective pharmaceuticals are developed and registered in a more efficient and rational manner. These new measures include amendments to the Pharmaceutical Affairs Law (the fundamental law regulating drugs) and other related lawse construction of a new system of drug review; and updating technical requirements for new drug registration based on the achievements of the International Conference on Harmonication (ICH). This paper will describe the current struction in Japan regarding the approval process for new drugs.

The legal basis of drug evaluation/registration and review system

Pharmaceurical administration in Japan is conducted according to a number of laws. For the implementation and management of these laws, detailed regulations are prepared by government and ministerial ordinances and notices, and notifications are issued by the Director General of the Bureau of the All BV or the directors of the Directors on the Directors of the Directors of the Directors decision in charge [1,2]. Among these laws and related sugnitatory documents, the Pharmaceutical Affairs Law (PAL) is the supreme law.

The purpose of the PAL is to regulate matters pertaining to drugs, including bioexchinological/biological products, quasi-drugs, cosmeries, and medical devices, to ensure their quality, efficacy and safety. It also promotes the development of drugs for rare deseases.

The principal legal basis of the drug evaluation/registration and review system is described in the PAL. The PAL has been revised several times since it was enacted in 1960 in order to meet, firstly, scientific developments in the pharmaceutical field secondly, public needs and demand for better quality, sale and effective pharmaceuticals, and finally, movement towards international harmonization on technical requirements for the registration of pharmaceuticals [3,4]. Some specific features of tevisions of the PAL and other related laws, which have secently been made, are as follows [4]:

1. The amendments strengthened the regulations concerning clinical trials performed both for new drag applications (NDAs) and post-marketing surveillance (PMS). Manufacturers are legally required to affaire to Good Clinical Practice (GCP) regulations, with legal repercursions if they do not. The legal bases for GCP inspections have also been fortified. At the same time, the Organization for Drug Adverse Drug Reaction (ADR) Relief, Research and Development Promotion and Proflact Review (the Drug Organization), a semi-governmental body authorized by MHW, has been legally empowered to perform consultations on clinical trials with the sponsors:

2. Improvement in the NDAPMS review system:

3. The efinical and non-efinical NDA and post marketing data submitted have to meet the legally stipulated standards. This reflects an improvement in the data to meet recent advances in the related sciences that are embodied in the EOI guideline:

 The requirements concerning ADR reports both during clinical trials and after marketing have been documented.

Organizations involved in the new drug application review and restructuring of the review system

Japan's MHW is in charge of improving and promoting social welfare, social security and public health. The MHW consists of home offices and external hodies. The home offices comprise the Minister's Secretariat, nine Bureaus, local branch offices and affiliated institutions. Up to 1997, there different negativations were mainly involved in NDA review: firstly, the Phanmaceutical Affairs Bureau (PAR), one of the nine MHW Bureaux secondly, affiliated institutions of MHW, namely the National Institute of Health Sciences (NIHS) and the National Institute of Health (NIH), which was renamed as the National Institute of Infectious Diseases (NIIDim 1997; and finally, the Central Pharmaceurical Affairs Council (CPAC), an advisors body to the Minister of Health and Welfure. which is composed of experts working in medical and pharmaceutical institutions and universities.
