Another strand of criticism sees Rawls's whole concept of justification as deeply flawed because of too many disanalogies to his own domestic theory. In this paper, I want to show that a great deal of this criticism is legitimate. In order to do this, I will first give a brief overview of Rawls's Law of Peoples and its most important differences to his domestic theory of justice. Afterwards, I will reconstruct Rawls's justification for the toleration of certain non-liberal peoples. Finally, I hope to show that this justification is highly problematic and a weakness that deeply influences the construction of Rawls's whole international theory.
