labor and political and religious liberals. Sizable elements among the minority group ranks developed a modicum of economic power and political influence for the first time during the Truman administration. This rudimentary power was among the bases for civil rights and racial developments after 1953. Although the civil rights story of the Truman administration is one relating mainly to blacks, this study deals with other minority groups including Indians, Mexican Americans, Puerto Ricans, Japanese and Chinese Americans, and Jews. Based on extensive research in primary source materials, it is a balanced in-depth analysis of the power of minorities in eliciting change.
