In 2015 Tony rented the stable block to Shula for seven years at an annual rent of £1,500. In 2018 Tony agreed in writing that his daughter Helen, who lived in April Cottage, had the right to buy April Cottage anytime during the next five years for the sum of £200,000.

Last month Tony sold Bridge Farm to Phil before moving to become a sheep farmer in Australia. After the sale, Phil told David to stop driving to Lakey Hill across Bridge Farm; and he informed Shula that she must leave the stable block immediately. They both refused. David was furious because he has no other way of getting to his sheep on Lakey Hill. Helen says she now wants to exercise her right to buy April Cottage. Phil was also surprised to hear from Jennifer, Tony's sister, who claims to have rights over Bridge Farm because she paid towards its purchase price.
