#### The Presiding Officer:

Above subject matter was referred to the Committee on Rules and Committee on Peace and Order and a Joint Committee Meeting was conducted on August 8, 2023 with PEMS Arnel C. Batara of Anao PNP as resource person. Below is the Joint Committee Findings and Recommendations.

#### FINDINGS:

- 1. That, per the Committee's further research regarding the matter. Section 2 of Republic Act No. 8551 provides that the PNP shall be a community and service-oriented agency responsible for the maintenance of peace and order and public safety.
- That, in line with the said provision of the law, the Commission issued Resolution No. 2015-342, entitled. "Resolution to Empower the Philippine National Police (PNP) to Perform its Role as a Community and Service-Oriented Agency Through the Adoption of the Community and Service-Oriented Policing (CSOP) System involving the Local Chief Executives, the PNP and the Community, as Mandated Under Section 2 of R.A. No. 6975, as amended by R.A. No. 8551".
- 3. That, Mayor Gian Pierre O. De Dios, in his letter dated July 14, 2023, requested the august Body to pass a Resolution authorizing him to enter into a MOA with NAPOLCOM regarding the implementation of CSOP System in the PNP;
- 4. That, PEMS Batara discussed the concept of the CSOP System and upon inquiry of the Committee Members, he mentioned three (3) possible groups, namely. Region 3 Road Warriors, United llocandia and Ciclista de Anao to join in the undertaking and enumerated the following programs to be undertaken in relation to CSOP:
  - a. Mobile/Foot Patrol

  - b. Oplan Tokhang
     c. Conduct of Buy Bust Operations
  - d. Conduct of Community-Based Reform Program (Balay Silangan)
  - e. Conduct of IEC Campaign on Illegal Drugs in all Barangays
  - Conduct of Trainings and Seminars to the barangay force multipliers
  - g. Project BE CAREFUL (Barangay Empowerment in Child Abuse resistance and Elimination-Fight Unwanted Lewd Design)
  - h. Anti-Criminality Checkpoints
  - Provide training/ IEC Campaign for the responsible motorists. 1.
- That, the abovementioned programs are in line with the approved Peace and Order and Public Safety Plan of the Municipality of Anac;
- 6. That, in the letter of Regional Director Julieta P. Raneses of NAPOLCOM Regional Office 3, they were just requesting for inputs/suggestions/recommendations as regard to the MOA to be submitted to their office through their email address on or before July 15. 2023
- 7. That, also mentioned in their letter is their plan to conduct Orientation on the Powers and Functions of LCEs as NAPOLCOM Deputies, Refresher on the CSOP System and MOA Signing on the 3rd Quarter of 2023;
