What is a misrepresentation?



A representation is a statement made at the time of the contract being made and can be incorporated into the contract.

If the representation is falsely made, however, it can be a misrepresentation and can cause the contract to be voidable.

Legal Definition:

A misrepresentation is a <u>statement of material fact</u>, made by <u>one party to a contract to the other party</u> to the contract, during the negotiations <u>leading up to the formation of the contract</u>, which was intended to operate and did <u>operate as an inducement</u> to the other party to enter the contract, but which was <u>not intended to be a binding obligation</u> under the contract, and which was <u>untrue or incorrectly stated</u>.
