how to answer the impossible question on the edexcel gcse maths - Mar 30 2022

web the sector has the same area as the sector we calculated earlier due to it again being a 60 sector with sides of 4cm its area is therefore $8\pi \text{ cm}^2$ the triangle s area can be calculated using the formula $\frac{1}{2} ab \sin c$ triangle area $\frac{1}{2} \times 4 \times 4 \sin 60 = \frac{1}{2} \times 16 \times \frac{\sqrt{3}}{2} = 4\sqrt{3} \text{ cm}^2$ note that we should remember that $\sin 60 = \frac{\sqrt{3}}{2}$
