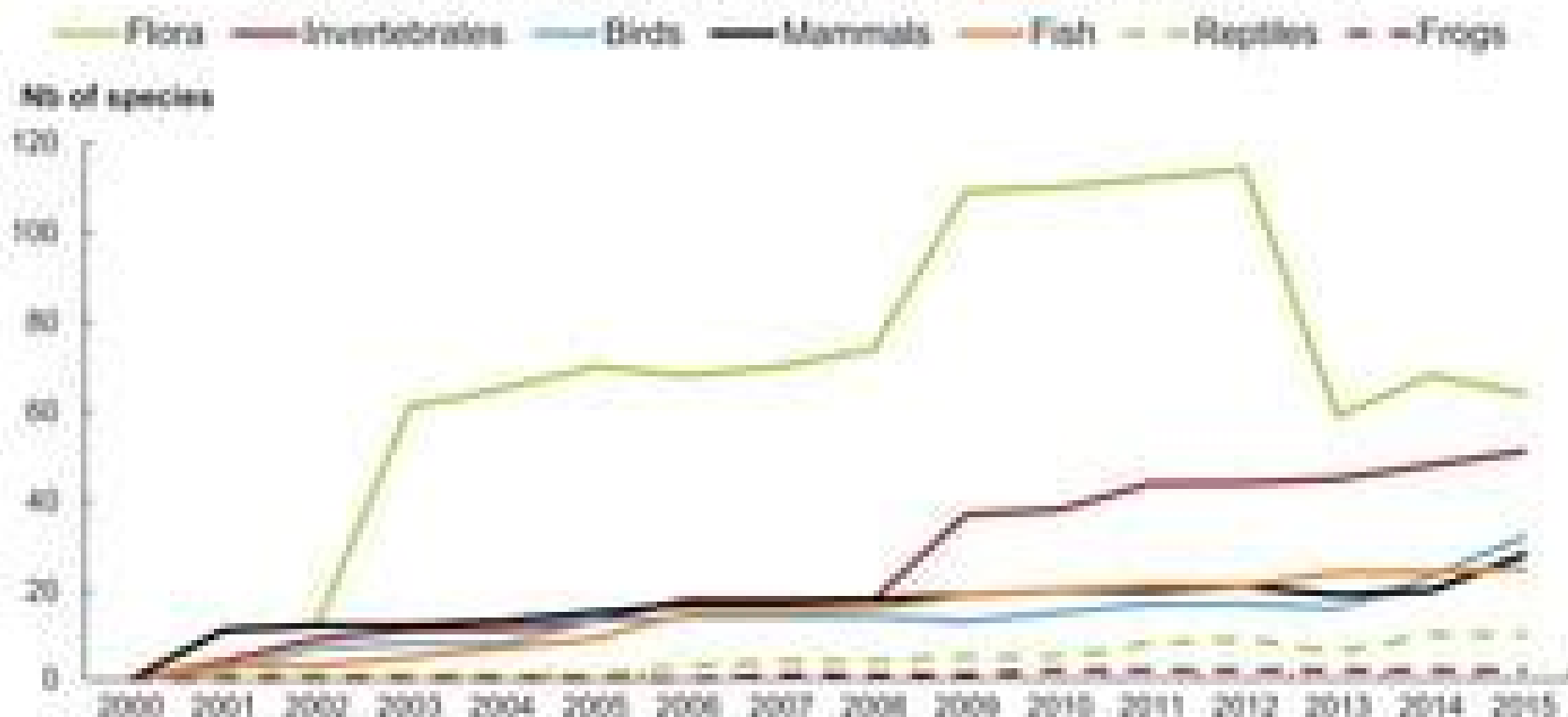




Threatened species numbers are increasing
