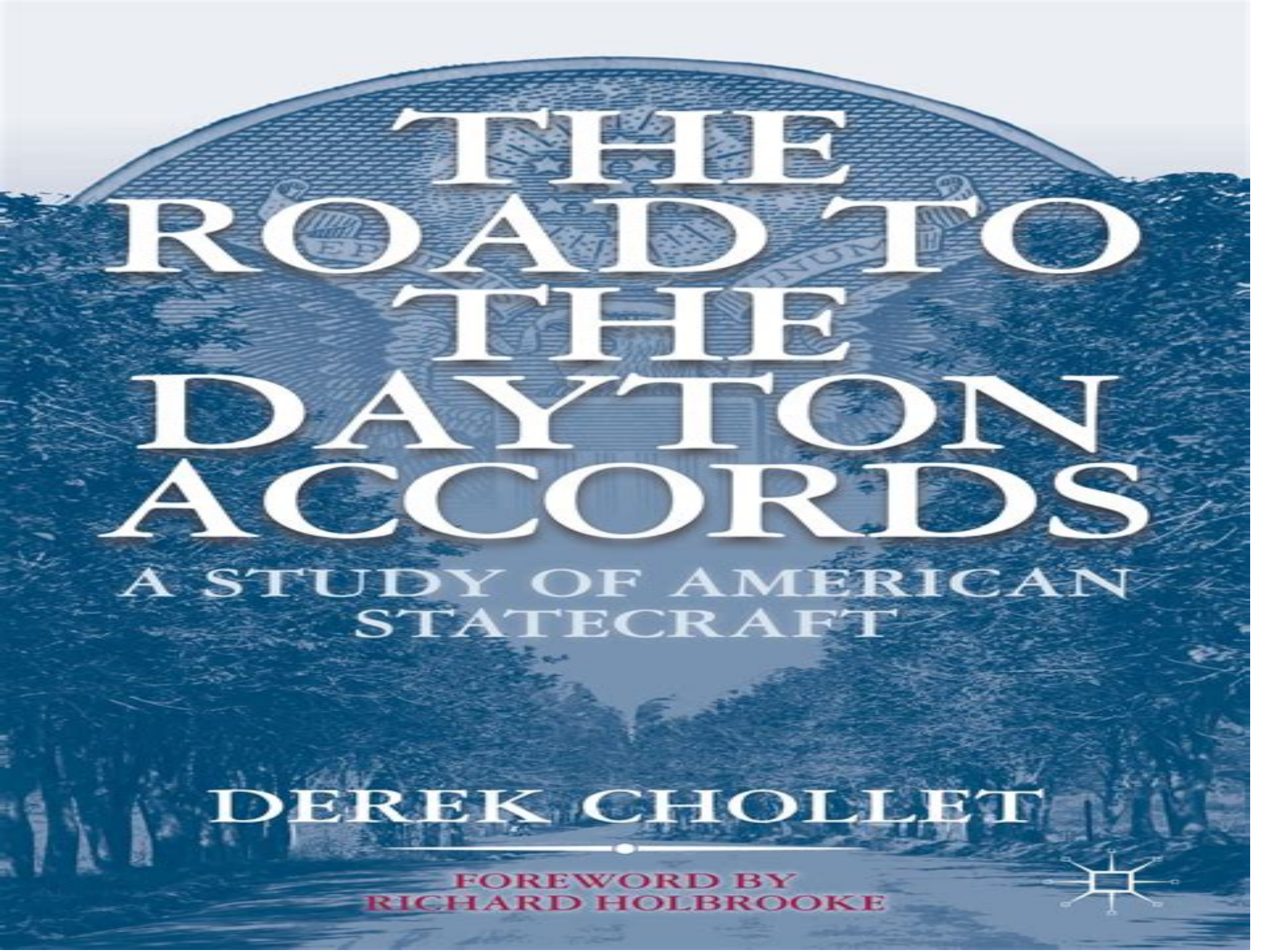

Statecraft 2.0 Dennis Ross, 2025 In a world that is multipolar and America has less relative power the United States no longer has the luxury to practice statecraft badly The United States may still be the world's strongest country but it now faces real challenges at both a global and regional level The unipolar world which was dominated by America after the Cold War is gone Unlike the Soviet Union China is both a military and economic competitor and it is actively challenging the norms and institutions that the US used to shape an international order during and after the Cold War Directly and indirectly it has partners trying to undo the American dominated order with Russia seeking to extinguish Ukraine and Iran trying to undermine American presence influence and any set of rules for the Middle East that it does not dominate The failures of American policy in Afghanistan and Iraq have weakened the domestic consensus for a US leadership role internationally Traditions in US foreign policy especially the American sense of exceptionalism have at different points justified both withdrawal and international activism Iraq and Afghanistan fed the instinct to withdraw and to end the forever wars But the folly of these US interventions did not necessarily mean that all use of force to back diplomacy or specific political ends was wrong rather it meant in these cases the Bush Administration failed in the most basic task of good statecraft namely marrying objectives and means Nothing more clearly defines effective statecraft than identifying well considered goals and then knowing how to use all the tools of statecraft diplomatic economic military intelligence information cyber scientific education to achieve them But all too often American presidents have adopted goals that were poorly defined and not thought through In Statecraft 2.0 a significant update of the first edition Dennis Ross explains why failing to marry objectives and means has happened so often in American foreign policy He uses historical examples to illustrate the factors that account for this including political pressures weak understanding of the countries where the US has intervened changing objectives before achieving those that have been established relying too much on ourselves and too little on allies and partners To be fair there have not only been failures there have been successes as well Ross uses case studies to look more closely at the circumstances in which Administrations have succeeded and failed in marrying objectives and means He distills the lessons from good cases of statecraft German unification in NATO the first Gulf War the surge in Iraq 2007-8 and bad cases of statecraft going to war in Iraq 2003 and the Obama policy toward Syria Based on those lessons he develops a framework for applying today a statecraft approach to our policy toward China Iran and the Israeli Palestinian conflict The book concludes with how a smart statecraft approach would shape policy toward the new national security challenges of climate pandemics and cyber

Bosnia Remade Gerard Toal, Carl T. Dahlman, 2011-02-16 Bosnia Remade is an

authoritative account of ethnic cleansing and its partial undoing from the onset of the 1990s Bosnian wars up through the present Gerard Toal and Carl Dahlman combine a bird's eye view of the entire war from onset to aftermath with a micro level account of three towns that underwent ethnic cleansing and later the return of refugees There have been two major attempts to remake the ethnic geography of Bosnia since 1991 In the first instance ascendant ethno nationalist forces tried to eradicate the mixed ethnic geographies of Bosnia's towns villages and communities These forces devastated tens of thousands of homes and lives but they failed to destroy Bosnia Herzegovina as a polity In the second attempt which followed the war the international community in league with Bosnian officials endeavored to reverse the demographic and other consequences of this ethnic cleansing While progress has been uneven this latter effort has transformed the ethnic demography of Bosnia and moved the nation beyond its recent segregationist past By showing how ethnic cleansing was challenged Bosnia Remade offers more than just a comprehensive narrative of Europe's worst political crisis of the past two decades It also offers lessons for addressing an enduring global problem

Reversing Ethnic Cleansing through Minority Returns Rebecca A. Brubaker, 2025-02-07 Ethnic conflict is not new Nor are international attempts to prevent or contain it Reversing Ethnic Cleansing through Minority Returns examines whether and how ethnic religious and political minorities should be returned and reintegrated after conflict Its main focus is the unprecedented international attempt to re mix ethnic groups in Bosnia following the war The book scrutinizes the puzzle of why states and international organizations pursued a re mixing policy in response to ethnic cleansing in Bosnia There were multiple policy alternatives on the table at the start of the conflict Compared to these re mixing was an unlikely choice politically it was risky locally it was unpopular financially it was expensive and practically it ultimately failed Yet Washington and the United Nations chose to prioritize re mixing nonetheless justifying their choice on the grounds that it was essential for reversing ethnic cleansing and thereby re establishing a multi ethnic Bosnia More generally this book offers insights into how refugee return policies emerge evolve and solidify in a European context In doing so it contributes to a better understanding of how normative discourses transform into policy as well as offers policy recommendations for approaching the challenge of facilitating returns and reintegration following a war's end Understanding how and why such unintended norm diffusion emerged is a crucial addition to the historical record and provides an important correction to the lessons normally drawn from this precedent breaking case

approval for the 2003 Iraq War In *Reassuring the Reluctant Warriors* Stefano Recchia addresses this important question by drawing on declassified documents and about one hundred interviews with civilian and military leaders The most assertive hawkish and influential civilian leaders he argues tend to downplay the costs of intervention and when confronted with hesitant international partners they often want to bypass multilateral bodies America s top level generals by contrast are usually reluctant warriors who worry that intervention will result in open ended stabilization missions consequently the military craves international burden sharing and values the potential exit ramp for U S forces that a handoff to the UN or NATO can provide Recchia demonstrates that when the military speaks up and clearly expresses its concerns even strongly pro intervention civilian leaders can be expected to work hard to secure UN or NATO approval if only to reassure the military about the likelihood of sustained burden sharing Conversely when the military stays silent as it did in the run up to the 2003 Iraq War bellicose civilian leaders are empowered the United States is then more likely to bypass multilateral bodies and it may end up carrying a heavy stabilization burden largely by itself Recchia s argument that the military has the ability to contribute not only to a more prudent but also to a more multilateralist U S intervention policy may be counterintuitive but the evidence is compelling

Overcoming Obstacles to Peace James Dobbins,2013 This volume analyzes the impediments that local conditions pose to successful outcomes of nation building interventions in conflict affected areas Previous RAND studies of nation building focused on external interveners activities This volume shifts the focus to internal circumstances first identifying the conditions that gave rise to conflicts or threatened to perpetuate them and then determining how external and local actors were able to modify or work around them to promote enduring peace It examines in depth six varied societies Cambodia El Salvador Bosnia and Herzegovina East Timor Sierra Leone and the Democratic Republic of the Congo It then analyzes a larger set of 20 major post Cold War nation building interventions The authors assess the risk of renewed conflict at the onset of the interventions and subsequent progress along five dimensions security democratization government effectiveness economic growth and human development They find that transformation of many of the specific conditions that gave rise to or fueled conflict often is not feasible in the time frame of nation building operations but that such transformation has not proven essential to achieving the primary goal of nation building establishing peace Most interventions in the past 25 years have led to enduring peace as well as some degree of improvement in the other dimensions assessed The findings suggest the importance of setting realistic expectations neither expecting nation building operations to quickly lift countries out of poverty and create liberal democracies nor being swayed by a negative stereotype of nation building that does not recognize its signal achievements in the great majority of cases Page 4 of cover
