

Treatment against patient's will and its termination



- During hospitalization necessary medical actions are conducted in order to eliminate causes of admission without patient's consent.
- Coercion can be used in order to perform medical actions and to prevent from leaving hospital.
- A patient, his/her statutory representative, a spouse, siblings, direct relatives or other persons having custody of a patient
 - after 30 days from validation of a court decision about hospitalization, can apply for hospital discharge.
- A chief physician in hospital ward decides about discharge, if premises for hospitalization terminated.
- It is possible for a patient to stay in hospital, if he/she agrees and his/her treatment is justified.
- A court should be informed about circumstances mentioned above.
- If a chief physician refuses discharge on application of persons mentioned
 - within 7 days from the refusal they can apply to court.
