Broyld, 2022-05-25 Winner of the OHS Fred Landon Award In the early nineteenth century Rochester New York and St Catharines Canada West were the last stops on the Niagara branch of the Underground Railroad Both cities handled substantial fugitive slave traffic and were logical destinations for the settlement of runaways because of their progressive stance on social issues including abolition of slavery women's rights and temperance Moreover these urban centers were home to sizable free Black communities as well as an array of individuals engaged in the abolitionist movement such as Frederick Douglass Harriet Tubman Anthony Burns and Hiram Wilson dann j Broyld's *Borderland Blacks* explores the status and struggles of transient Blacks within this dynamic zone where the cultures and interests of the United States Canada Great Britain and the African Diaspora overlapped Blacks
