

argument that other terrorist groups multiply when they realize that terrorism succeeds in achieving political goals Proponents of the no concessions doctrine have argued that there is a pattern in terrorist contagion which results from giving in to their demands Statistical evidence for terrorist contagion is not convincing enough however as depicting an increase in terrorist incidences as a consequence of concessions could merely imply a flawed causality Without an explanation for such correlations we are left wondering whether other reasons could be decisive in the increase in terrorist
