The so called neoliberal revolution of the 1990s triggered by the Washington Consensus did not really change the interventionist innuendo of these policies but merely restated the social welfare goal to be achieved the pursuit of economic efficiency Dr De Leon presents his case against the assumption that consumer welfare orientated policies such as antitrust do really promote entrepreneurship and market goals Paradoxically antitrust enforcement has undermined the transparency of market institutions in the name of promoting market competition The author's provocative analysis marshals several sets of facts in support of his thesis including the actual functioning of antitrust policy as reflected in case law in various Latin American countries the preference of merger control over other less intrusive forms of market surveillance the constrained role of competition advocacy against government acts and the
