metaproteomics metabolomics and culturomics we are now able to begin to correlate the presence as well as the activities of specific organisms and microbial communities with health or disease However we are only beginning to understand the complexity of interactions between bacterial community members with each other and the human host A better understanding of these relationships within this specialized environmental niche and in relation to female sexual and reproductive health is critical for the development of novel diagnostics and therapeutics to create and maintain an optimal FRT microbiome
