the law So our analysis of law enables us to avoid the extreme views that have thus far dominated debates concerning the nature of legal interpretation On the one hand it becomes possible to avoid the cynical view held by the so called legal realists that legal interpretation is mere legislation and that no legal interpretation is more correct than any other On the other hand it becomes possible to avoid Blackstone s view rightly described by Austin as a childish fiction that judges merely discover and do not create the law
