SUSPENDED SENTENCE

- A suspended sentence is a judgment that is passed but <u>not</u> <u>carried out</u> as long as the offender meets certain conditions set out by the judge;
- Suspended sentences can only be imposed for offences that have NO minimum punishment required by the Criminal Code;
- These are usually given for <u>first-time</u> or <u>minor offences</u>, or in the situation where the judge feels that the knowledge of the sentence alone is sufficient to keep the offender in line...
