Types of Agreements

The closest relation I had to marriage agreements for an example. There are different agreements that can be included in the marriage contract. They are: **Marriage Agreements, Prenuptial Agreements, Separation Agreements and Divorce Settlement Agreements.** The main agreement between spouses should consider their relationship separately.

Prenuptial Agreements: The contract is "before" from the spouse where they are agreement before marriage about everything. This agreement includes the property and assets of each spouse during marriage, the property and assets acquired by the spouse during the marriage without financial interest of property and assets before or the result of divorce.

Prenuptial Agreement: This is an agreement made about marriage, for marriage that the property acquired by law. The division of property and assets, and other things for the result of divorce. The marriage should be defined by law, as the law governing that the right to divide the property and assets during divorce.

Separation Agreements: The agreement where both the spouses agreed to live separately and apart in a separation agreement. This agreement includes the child custody, maintenance of the child and what the spouse. During the time of separation of spouse, they have to handle the child support, child custody and sharing of assets, including and divorce.

Separation of maintenance agreement: This is an Agreement where both the spouses agree to get out of their marriage. While the spouse should agree that they must get separated for the agreement without the involvement of the court. This agreement is also called a financial maintenance agreement. This includes the property, assets, maintenance of spouse, child custody and separation/maintenance without the involvement of the court.

These agreements are generally the influenced by any other spouse. These agreements cannot challenge in the court. The court may decide the case when they come to the judge that the agreement is not valid. If these agreements are not valid or reasonable, the court has the authority to make a the agreement is invalid.
